I refer to your request under the Freedom of Information Act, 2014 for access to records held by this hospital.

Your request dated 29 August 2018, was received in this office on the 31 August 2018.

I, **Example 1** have now made a final decision to grant your request on 09th October 2018. Accordingly, a copy of the records is now attached.

We are unable to provide, with complete accuracy, the number of hospital consultants by specialty who have *applied* in each of the past five years to change to a part-time public commitment and/or career break/leave of absence. However, please find attached;

- 1. The number of hospital consultants by specialty who have applied in each of the past five years to change to a part-time public commitment which was granted;
- 2. The number of hospital consultants by specialty who have applied in each of the past five years for a career break/leave of absence which was granted.
- 3. The number of hospital consultants by specialty who have resigned in each of the past five years.

In the event that you are not happy with this decision you can make an appeal in relation to this matter, you can do so by writing to the Freedom of Information Unit, Beaumont Hospital. Beaumont Road, Dublin 9 or by e-mail to foi@beaumont.ie. You should make your appeal within 4 weeks (20 working days) from the date of this notification, where a day is defined as a working day excluding, the weekend and public holidays, however, the making of appeal

may be permitted in appropriate circumstances. In relation to an appeal regarding this decision there is a fee payable in the amount of \in 30

The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this body.
